# A RESOLUTION OF THE SOLDIER TOWNSHIP, KANSAS TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

**WHEREAS,** the Revenue Neutral Rate for the Soldier Township was calculated as 14.507 mills by the Shawnee County Clerk; and

WHEREAS, the budget proposed by the Governing Body of the Soldier Township will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Governing Body held a hearing on September 6, 2022, allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and

**WHEREAS**, the Governing Body of the Soldier Township, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE SOLDIER TOWNSHIP:

The Soldier Township shall levy a property tax rate exceeding the Revenue Neutral Rate of 14.507 mills.
